fiberglassing of #48 was actually done by Bruce Hammatt Sr and his son, Merv Hammatt. Bruce Jr was away at college when the work was done in the spring of 1963. The boat had been out of the water, outside, for 4-5 years and needed a fair amount of work. The deck was glassed and new oak coamings were done at the same time. Bruce Sr had a fair amount of glassing experience, covering Baybirds and then building 10 all glass Baybirds. He also covered a 32 ft knockabout, Tioga, in the late 1950's. These were all boats used at Camp Quanset. He made some extra spending money by covering wooden boats for others during this time period. His experience glassing boats is reflecting that Pyxis is still sailing 50 years later.
